On Friday, March 27, 2020, President Trump signed into law the Coronavirus Aid, Relief, and Economic Security Act of 2020 (or "CARES" Act) (Pub. L. No. 116-136) (H.R. 748). The Act provides more than \$2 trillion in emergency economic relief for businesses, families, and individuals affected by the coronavirus pandemic (COVID-19)—the largest stimulus or rescue package in American history. The Act represents the third piece of legislation intended to help families and companies impacted by COVID-19.
