Bipartisan House Task Force Report on Artificial Intelligence

The task force identified several high-level **principles** to guide AI policymaking and lay a foundation for balanced governance, such as:

- Assess whether AI introduces genuinely new challenges or amplifies existing ones
- Prioritize policies that maintain US leadership in AI development
- Develop a risk-based approach to mitigate accidental and malicious AI misuse
- Encourage federal adoption of AI to enhance service delivery, efficiency, and public trust
- Leverage sector-specific expertise to address domain-specific AI challenges
- Recognize the evolving nature of AI and create flexible policies
- Complement human decision-making and preserve individual freedom

The report presents a forward-looking vision for AI governance that balances innovation with the need to protect public interests. By adhering to its guiding principles, policymakers can craft regulations that encourage technological progress while addressing ethical, legal, and societal concerns. This approach is intended to position the US to lead in the responsible development and deployment of AI, ensuring its benefits are equitably distributed and its risks effectively managed.
