- *The Detroit News v. Independent Citizens Redistricting Comm'n*, 508 Mich. 399 (2021), through an original action in the Michigan Supreme Court, successfully challenged the

- *In re OSHA Covid Rule*, No. 21-7000 (CA6 2021), coauthored amicus brief for the Small Business Association of Michigan in opposing OSHA's emergency temporary standard for mandatory vaccination.
- *Bisio v. City of Clarkston*, 506 Mich. 37 (2020), authored amicus brief for members of the press on the application of FOIA to local municipal officers.
- *Henry v. Dow Chemical Co.*, No. 156128 (Mich. 2018), authored amicus brief for the Michigan Defense Trial Counsel on the statute of limitations and Michigan's claim-accrual statute in an environmental case involving the contamination of the Tittabawassee River.
- *People v. Brown*, 500 Mich. 1018 (2017), on special appointment by the Michigan Supreme Court, secured a new appeal of right for a prisoner on a claim of ineffective assistance of appellate counsel.
- *Bitterman v. Bolf*, No. 151520 (Mich. 2016), authored amicus brief for members of the press favoring broad application of Michigan's Open Meetings Act to delegates performing statutory functions for public bodies.
- *Polytorx, LLC v. University of Mich.*, Nos. 318151, 320989 (Mich. App. 2015), secured an interlocutory reversal in a trade-secrets case that resulted in a pre-discovery judgment in favor of the University.
- *Kurns v. Railroad Friction Prods. Corp.*, No. 10-879 (U.S. 2012), authored amicus brief favoring federal preemption of all state common-law claims for injuries caused by locomotive equipment.

Notable Criminal Matters:

- Secured a full acquittal of a board-certified pain management physician charged with 39 counts of drug trafficking, healthcare fraud, and maintaining a drug-involved premises.
- Represented former Ford employee charged with stealing \$50 million in trade secrets.

- Secured probation for a physician accused of a \$9 million healthcare fraud.
- Investigated allegations of sexual abuse by a physician for a healthcare institution that provided medical care to juveniles held in custody.

- Settled a government enforcement action against a nonprofit without a fine when the government intended to shut down the nonprofit for alleged fraud.

- Defended numerous L-1 nonimmigrant work visa holders accused of criminal offenses, successfully resolving several actions in ways that avoided negative impact to visas.

Notable First Amendment Matters:

- *U.S. v. Fox*, No. 20-183 (WD Mich. 2021), secured the partial release of pretrial detention exhibits for *BuzzFeed* and *The New York Times* in a case against one of the men accused of conspiring to kidnap the governor of Michigan.
- *Kolodin v. William Beaumont Hosp.*, No. 343445 (Mich. App. 2019), successfully defended a dismissal of a defamation action premised upon a mandatory report under the Child Protection Law.
- *Levitt v. Digital First Media*, No. 330946 (Mich. App. 2017), secured interlocutory reversal and dismissal of case after a trial ruling that allowed a lawyer to proceed with a defamation claim against a newspaper.
- *Montcalm County v. Greenville Daily News*, No. 16-K21647-CZ (Mich. Cir. Ct. 2016), secured dismissal of lawsuit filed by a county against a newspaper over its FOIA request.
- *People v. Leist*, No. 14-49-FY (Mich. Dist. Ct. 2014), secured dismissal of criminal charges against a photographer over photographs of an airplane crash site.
