LICENSING AND REGULATION

Product Recall (2/26/2019)


On February 26, 2019, the FDA issued a recall of certain Utopia Concentrates and Utopia Cartridges due to the sale of marijuana.

The products were sold by Utopia in Detroit.

The affected products include:

- **Utopia Concentrates** | 1A4050100000641000000066 | Failed for chemical residue
- **Utopia Cartridges** | 1A4050100000641000000066 | Failed for chemical residue

Additionally, BMR issued an updated bulletin in which one product—Lemon Cake—was added to the original recall of nine products from 664 Vassar, LLC (Elite Wellness Vassar) in Vassar.

The affected products include:

- **Lemon Cake (Flower)** | 1A405010000089B000000348 | Failed for chemical residue

Patients or caregivers who have these affected medical marijuana products in their possession should return them to the provisioning center for proper disposal.

Product Recall (2/11/19):

The Michigan Department of Licensing and Regulatory Affairs (LARA) has issued a health and safety advisory recall due to the sale of marijuana which failed laboratory testing. The products were sold between November 13, 2018 and February 1, 2019, at 664 Vassar, LLC (Elite Wellness Vassar), located at 664 State Road, Vassar, MI (License PC-000035).

Patients or caregivers who have these affected marijuana products in their possession should return them to 664 Vassar, LLC (Elite Wellness Vassar) for proper disposal.

Product Recall (2/7/19):

The Michigan Department of Licensing and Regulatory Affairs (LARA) has issued an updated health and safety advisory due to the sale of marijuana that failed laboratory testing. Two additional products – “Purple Sherbet #2” and “Do Si Do”—were added to the original recall of four products from The Green Mile Detroit, which was issued on January 10, 2019.
