DETROIT, Mich. – **Butzel Long** attorney and shareholder **David F. The presentation will focus on the first step to combat fraud practices which is prevention.

Mr. DuMouchel is a Fellow of the American College of Trial Lawyers and serves as a member of the criminal procedure and Michigan State Committees. He is a recipient of the Federal Bar Association's Leonard Gilman Award as the outstanding criminal law practitioner in the Eastern District of Michigan.

In 2004, Mr. DuMouchel, along with Laurie J. Michelson, gained their client's acquittal in one of the largest health care fraud trials in history in the U.S. District Court in Boston.

Mr. DuMouchel is a *cum laude* graduate of Wayne State University Law School (J.D., 1975) and the University of Detroit (M.A., 1972).
