## James S. Rosenfeld appointed to the DMBA Board of Directors

Mr. Rosenfeld is a graduate of Georgetown University Law Center (J.D., 1986) and Harvard College (A.B., 1981, *magna cum laude*). He is a resident of Huntington Woods.
