Justice Wilder, the 112th Justice of the Michigan Supreme Court, graduated from the University of Michigan with an A.B. degree in Political Science in 1981, and from the University of Michigan Law School with a Juris Doctor degree in 1984.

Notably, Justice Wilder was named to Michigan Lawyers Weekly's Hall of Fame Class of 2021.

In 2021, Justice Wilder was elected Chair of the Interlochen Center for the Arts Board of Trustees. Previously, he served as First Vice-Chair and Chair-Elect.

In 2020, Justice Wilder was elected Secretary of the Board of Directors of the Detroit Symphony Orchestra. Justice Wilder also serves on the Boards of the Alumni Association of the University of Michigan, Detroit Regional Dollars for Scholars, and The Children's Foundation.

Moreover, Justice Wilder is an Elder and Chancel Choir member at First Presbyterian Church of Plymouth, and has memberships in the Fellows of the Michigan State Bar Foundation and the Wolverine Bar Association.

He is a Past President of the Michigan Judges Association, and Past Chairman of the State Bar of Michigan Judicial Conference.
