Representative Matters

- **Mortgage Servicing & Lender Litigation**
 - Represented a leading New York mortgage servicer trade organization in an *amicus* filing to the New York Court of Appeals to hear and settle a matter of great significance regarding how the statute of limitations is calculated for mortgage foreclosure actions.
 - Defended large financial services institutions in a federal action seeking relief from purported violations of a pooling and servicing agreement for mortgage backed securities. Obtained a dismissal of all charges in the district court, and the ruling was affirmed by the Second Circuit.
