# Representative Matters

- After we conducted oral argument and briefing, the Richmond County Supreme Court granted our request for summary judgment on behalf of our client, a national mortgage servicer, in a foreclosure action. The defendants' counterclaim for intentional infliction of emotional distress was dismissed.
- After a computation hearing, the foreclosure referee issued a report that
  found the full requested amount to be due. Upon moving to confirm the
  report and for a judgment of foreclosure and sale, the Rockland County
  Supreme Court approved it without imposing any sanctions on our client,
  which the court had previously threatened to impose.
- Following briefing and oral argument, the Kings County Supreme Court denied the defendant's motion to dismiss under the statute of limitations and granted summary judgment in favor of our client in a foreclosure action.
