Representative Matters

- Secured a full dismissal for a national mortgage lender in a nationwide FDCPA class action, followed by a summary affirmance from the U.S. Court of Appeals for the Third Circuit. Obtained a preclusion order against vexatious plaintiffs and an order for attorney's fees covering the full defense costs.
- Led the defense of an auto loan lender in a nationwide class action with potential statutory damages exceeding \$250 million. Used motion practice to secure an early favorable settlement on an individual basis and dismissal of all class claims.
- Aggressively defended a national bank in a multimillion-dollar UCC class action, defeating extensive class-wide discovery demands and negotiating a settlement far below potential damages after opposing class certification.
- Achieved summary judgment on fraud and negligence claims and defended the ruling on appeal, securing an affirmance by the Pennsylvania Superior Court.
