She counsels employers on all aspects of the employment relationship and represents employers in litigation matters. Recently she obtained a favorable ruling on behalf of an employer in an arbitration matter that preserved important management rights involved in the hiring process.

A graduate of Loyola University Chicago School of Law, she has been an adjunct professor at her alma mater for 12 years, teaching Employment Law and Employment Discrimination. She serves as pro bono counsel for Voices for Illinois Children.

**Nicholas Legatos** heads Hinshaw's Real Estate Practice and represents clients throughout the U.S. in a wide variety of real estate-related transactions. His Crain's profile notes that Legatos has represented a developer in a \$1 billion project to transform a Texas industrial campus into a mixed-use, sustainable development.
