Hinshaw Announces Miami Office Move to The Plaza in Coral Gables

The Coral Gables office favors a return-to-office approach and will also offer a flexible schedule for lawyers working remotely. Approximately 42 attorneys and 33 staff members for a total of 75 employees have made the move, and the space includes room for growth. There are 38 exterior offices with an average office size of 130 square feet, three conference rooms for meetings, and separate areas for breakout sessions. Formerly located at 2525 Ponce de Leon Blvd. on the fourth floor, Hinshaw has had a presence in Coral Gables since 2012.
