### Two Hinshaw Partners Selected to New Orleans CityBusiness 2024 Women of the Year

Jarrott is a partner and co-leader of Hinshaw's Energy and Environment industry groups. She advises energy companies across Louisiana on legislative and regulatory matters related to oil & gas matters and carbon capture, utilization, and sequestration (CCUS).
