Mr. Seaman has a long track record of successfully representing companies before trial courts, appellate courts, and arbitration panels across the country in high-stakes matters, including cases and cessions involving general liability coverage (primary, umbrella and excess), professional liability coverage, first-party property coverage, bad faith and extra-contractual matters, fee disputes and facultative and treaty reinsurance contracts. He has served as national coverage counsel, as well as trial and appellate counsel. He also advises companies on emerging issues and a wide range of case-specific and portfolio issues. Mr. Seaman also handles international, professional liability, tort and product liability, and business and commercial matters.
