

During her last year at the Puerto Rico Treasury Department, she participated in the implementation of the Puerto Rico Internal Revenue Code of 2011, working directly in the design, creation and revision of all forms and instructions, including individuals, corporations, flow-through entities, exempt businesses, estates and trusts.

Ms. González-Ibarría has been a speaker in seminars sponsored by the Puerto Rico Society of Certified Public Accountants and spoken in training sessions for the Puerto Rico Treasury Department. She also worked as a Tax Consulting Manager in the Tax Department of Ernst & Young in San Juan, Puerto Rico.
