Before that, Ms. Brochert practiced for several years with a New York City metro-area law firm where she represented insurers in complex coverage disputes involving multi-million dollar construction projects, severe personal injuries and exposures to toxic materials, as well as matters involving state and local government entities, including the city of New York.
