She is a junior member of the school's Moot Court and Law Review and a parliamentarian member of the Black Law Students Association. While in law school, she served as a summer intern for Judge Gershwin A. Drain of the U.S. District Court for the Eastern District of Michigan. Jackson received her undergraduate degree, *cum laude* in 2019, from the University of Michigan - Ross School of Business.
