Rounding out the Class of 2022 is Thakady who is set to receive her law degree in 2024. She received a full tuition academic merit scholarship to Wayne Law, and she is a member of the Women's Law Caucus. A 2019 graduate from the University of Michigan, Thakady received university honors for all semesters and participated in the university's study abroad program in Dublin, Ireland.
