

REPRESENTATIVE MATTERS

- Appointed by the United States District Court in Philadelphia to oversee and resolve discovery disputes in the Zoloft birth defects national multi-district litigation.

- Managed an eminent domain dispute concerning property valuation and the authority to acquire real estate for public infrastructure projects and energy initiatives, including a natural gas facility in Northeast Pennsylvania, encompassing highways and bridges.
- Purchase negotiation of a multi-unit apartment building.

- Arguments in 15 cases in the United States Court of Appeals for the Third Circuit, twice in the Pennsylvania Supreme Court, and additional arguments in intermediate Pennsylvania appellate courts.
