Eleven RCCB Attorneys Selected as 2018 PA Super Lawyers and Rising Stars

Litz, and Associate Alexander J. Nassar, are attorneys in RCCB's Litigation Group, while Partner David Kovsky and Counsel Erin McQuiggan are attorneys in the Private Client Services Group.
