

The annual selections are made using a patented multiphase process that includes a statewide survey of lawyers, an independent research evaluation of candidates and peer reviews by practice area. The result is a credible, comprehensive and diverse listing of exceptional attorneys.

The ten RCCB attorneys selected to the Rising Stars list span four practice groups; Litigation, Private Client Services, Business & Corporate and Real Estate. Partner Matthew Faranda-Diedrich, Partner Sean S. Litz, and Associate Alexander J. Nassar, are attorneys in RCCB's Litigation Group, while Associate Taylor Smith is an attorney in the Private Client Services Group.

Dustin Covello is a Partner in the Tax Group, Laura Reinhold, Matthew Brinker and David Dalesandro are Associates in the Business & Corporate Group, and Counsel Joshua Upin and Associate Jennifer Tintenfass are in the Real Estate Group. This is the ninth consecutive Rising Stars appearance for Faranda-Diedrich, also a Partner in the Business Restructuring and Bankruptcy Group, fifth for Nassar and Tintenfass, fourth for Covello and Litz, and third for



Brinker, Reinhold and Smith.

In addition, RCCB has three Partners previously selected as New York Super Lawyers. Business Restructuring & Bankruptcy Partners Marc Hirschfield and Marc Skapof have been named consecutively since 2011 and 2014 respectively, and Trademark Partner Donna Tobin has returned to the list for her second appearance.


