→ Biometric Information Privacy Act (BIPA)

The Biometric Information Privacy Act (BIPA) is an Illinois statute that took effect in October of 2008 and protects against the unlawful collection, use, and storage of biometric information, such as fingerprints, iris scans, and face prints. BIPA is one of three state laws that regulate collection of biometric information, but is the most stringent in terms of the consent, notice, and disclosure protocols private entities must follow. BIPA's reach extends to companies well outside of Illinois, and applies to any company that collects or otherwise uses the biometric data of individuals located in Illinois. Our work includes both BIPA litigation defense, as well as counseling for setting up biometric information collection and use programs.
