## Matters

- Defeated on the eve of trial headline-making mass toxic tort action spearheaded by Erin Brockovich. Plaintiffs alleged that nearly 1,000 current and former high school students were injured from exposure to over 140 chemicals from neighboring oil drilling sites and an energy production facility. Client Venoco, Inc. won on summary judgment and continues to operate its oil drilling facility today.
- Represented Samsung SDI America in class action litigation relating to the well known issues with the Note 7 smart phone. Case successfully defended by virtue of successful motion to compel arbitration and dismiss class claims.
- Represented Hehr International in recall action with the National Highway Safety Traffic Administration of its windows manufactured for buses across the United States and Canada, and subsequent product liability action.
