## **Experience**

### Trade Secrets, Technology and Intellectual Property Litigation

Won jury trial in New York State Supreme Court Commercial Division for financial management firm in a multimillion dollar trade secret, unfair competition, and corporate raiding case.

Won four-week jury trial for one of the largest manufacturers of OTC pharmaceuticals in a false advertising case arising out of comparative statements. Also prevailed on counterclaims.

Won multimillion dollar jury trial in licensing dispute on behalf of OTC manufacturer.
