# GovCon Cybersecurity Maturity Model Certification ("CMMC") Program

At long last, the Department of Defense ("DoD") has provided its interim rule, published in the Federal Register on September 29, 2020, amending the Defense Federal Acquisition Regulation Supplement ("DFARS") to set forth requirements for the Cybersecurity Maturity Model Certification ("CMMC") program, as well as new requirements for a "NIST SP 800-171 DoD Assessment Methodology." The interim rule is effective November 30, 2020, and comments to the interim rule should be submitted by November 30 as well. The panel will cover the DoD assessment methodology, the certification (CMMC) framework, and the new DFARS clauses.
