#### **Financings**

 Representing the Special Committee of the Board of Directors of Great Ajax Corp (NYSE: AJX) in its one-year loan agreement with a subsidiary of Rithm Capital Corp. (NYSE: RITM) for up to \$70 million. Rithm is a global asset manager focused on real estate, credit and financial services, and Great Ajax is a real estate investment trust.
