### Sheppard Mullin Named "Law Firm of The Year" by San Diego County **Bar Association**

The San Diego County Bar Association has named Sheppard, Mullin, Richter & Hampton LLP the recipient of its Law Firm of the Year Award. Sheppard Mullin is the first-ever recipient of the award, one of the 2002 Public Service Awards announced by the SDBCA.

This translates into services, contributions, and expenses in excess of \$2 million. "Whether it's in the areas of immigration, domestic violence, AIDS, low-income housing, or otherwise, the indigent in San Diego County have important, real-life legal needs that often go unmet," said Robert Gerber, Chairman of the firm's Pro Bono Committee and an Intellectual Property partner in the firm's San Diego office. "As part of this community, we're doing what we can to help meet those needs. Sheppard Mullin is grateful to the San Diego County Bar Association for recognizing our efforts."

Gerber received national media recognition for his successful pro bono representation of Geovanni Hernandez-Montiel in 2000. In the landmark immigration case, a federal appeals court for the first time established persecution based on sexual identity as grounds for asylum. Gerber's work earned him the Tom Homann Law Association's President Award for the year 2000.
