#### **Mergers & Acquisitions**

- Represented 1871, Chicago's digital technology hub and the #1 ranked private business incubator in the world, in its agreement to acquire Catapult Chicago's intellectual property assets and programs. Catapult Chicago helps initiate powerful connections and offers programming for start-up founders and their leadership teams. Following the acquisition, members of both organizations will join together under the 1871 name. In February 2020, Sheppard Mullin also advised 1871 in adding the growth-stage programming of Illinois Technology Association (ITA), and the agreement with Catapult further adds to 1871's momentum by building a new and necessary bridge between early stage businesses and growth-stage companies.
