EXPERIENCE

Don has recently counseled administrative agents and lenders with respect to a \$180 million senior secured credit facility to an agribusiness company, a \$175 million senior credit facility to a professional services company and a \$100 million senior secured credit facility to a grain and seed storage and merchandising company.
