

With Court Ruling, Stinson Attorneys Can Pursue Fraud Claims in Roman Catholic Diocese of Harrisburg Bankruptcy

Church Officials Cannot Shield an Estimated \$95 million in Assets

The Committee of Tort Claimants in the Diocese of Harrisburg, who are represented by Stinson LLP attorneys [Robert Kugler](#) and [Edwin Caldie](#), can investigate and litigate fraud claims against two trusts established by Catholic officials. The decision to grant derivative standing by Chief Bankruptcy Judge Henry Van Eck opens the door to survivors of clergy sex abuse to seek recovery of \$95 million in assets.

The assets consist of over \$50 million in real estate held by the Roman Catholic Diocese of Harrisburg Real Estate Trust and over \$40 million of assets led by the Roman Catholic Diocese of Harrisburg Charitable Trust. Despite the Harrisburg Diocese's arguments, the judge found that Pennsylvania state law allows an unincorporated religious entity to hold title to property, and that the fraudulent nature of the diocese's transfers of its real and non-real assets to the trusts could not have been reasonably known to the diocese's creditors until after the diocese filed for bankruptcy. With Judge Van Eck's ruling, the purpose in creating such trusts can be determined, and whether or not the transfers were done fraudulently in order to escape financial responsibility.

Kugler said the abuse survivors feel gratified and empowered by the judge's ruling, and he expects the pursuit of the assets held in trusts might take the next year to unfold.
