Eve spent the first nine years of her legal career as a central Ohio trial lawyer. In 1988, she became the first woman elected judge of the Franklin County Common Pleas Court. She was appointed to the Ohio Supreme Court by Governor George Voinovich in 1996 and was elected by Ohio voters to three six-year terms.

Eve is also a dedicated public servant. While serving on the Ohio Supreme Court, she formed and chaired the Supreme Court of Ohio Advisory Committee on Mental Illness & the Courts, which since its formation in 2001 has helped establish 45 mental health courts, recommended changes to Medicaid and advocated for a new Juvenile Competency Statute. She served for 8 years with former Ohio Attorney General Mike DeWine as co-chair of the Attorney General's Task Force on Criminal Justice and Mental Illness, and continues as co-chair with Attorney General Yost. She is on Governor DeWine's Ohio Recovery Advisory Council, which advises the governor on addiction and mental health policy issues. Eve has also advocated nationally for the development of veterans' treatment courts, which assist returning
