## Vorys Advises ATSG in its Agreement to Sell to Stonepeak Partners LP for \$3.1 Billion

Vorys has represented Air Transport Services Group, Inc. (Nasdaq: ATSG) in its entry into a definitive agreement to be acquired by Stonepeak Partners LP in an all-cash transaction with an enterprise valuation of approximately \$3.1 billion. This transaction, announced on November 4, 2024, is expected to position ATSG to further expand its global presence in the air cargo leasing market and enhance its service offerings to customers. Under the terms of the agreement, holders of ATSG's common shares will receive \$22.50 per share in cash, which represents a premium of approximately 29.3% over ATSG's closing share price on November 1, 2024, the last full trading day prior to the transaction announcement. The parties expect to close the deal in the first half of 2025, pending approvals from regulators and ATSG stockholders.
