OVERVIEW

David Marion concentrates his practice on complex business litigation, antitrust and securities class actions, legal malpractice defense, first amendment/communications law and alternate dispute resolution. He acts as both plaintiffs and defense counsel in such litigation.

David has achieved numerous noteworthy court victories, including seven-figure jury verdicts in an unfair competition case against a major broadcast network, and in a vertical price-fixing case; defense of a major public utility in a precedent-setting federal ERISA class action; and victories in the U.S. Supreme Court and numerous state and federal appellate courts. He was appointed by the U.S. District Court as Receiver on motion of the Securities and Exchange Commission in an action involving a Ponzi scheme, and as special master in complex federal multi-district litigations.

RECOGNITION AND INVOLVEMENT

David was elected Chancellor of the Philadelphia Bar Association and is former President of the Philadelphia Lawyers Club. He is the National Chancellor of the Tau Epsilon Rho Law Society. He was elected as a Fellowship in the American College of Trial Lawyers, the International Academy of Trial Lawyers and the American Academy of Appellate Lawyers, and has held leadership positions in a number of non-profit organizations.

David received the James Wilson Award for service to the profession, school and community, the highest honor Penn Law School extends to an alumnus, and was the recipient of the Judge Learned Hand Award from the American Jewish Committee. He has been listed in Chambers USA as a leading lawyer in commercial litigation since the honor's inception in 2003 and is described as a "very highly regarded trial attorney." Since 2004, in surveys of his peers, David has been selected as a Pennsylvania "Super Lawyer." 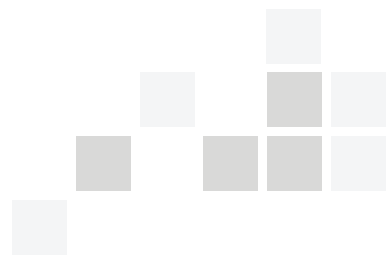
