### REPRESENTATIVE MATTERS

Defense counsel for eight years, retained by seven different insurance companies, to defend a leading Philadelphia area home developer in over 200 individual stucco claims involving dozens of different homeowner attorneys; in parallel litigation that we did not handle, these claims led to the leading appellate construction defect insurance coverage decision in Pennsylvania and one of the more significant coverage decisions in the country.

Defense counsel for a developer and general contractor in litigation in Baldwin County, Alabama involving multiple construction defect claims in five high-rise condominium buildings in Gulf Shores and Orange Beach, Alabama; successfully resolved a middle eight-figure case for a fraction of the claimed damages, and secured substantial contributions from subcontractors, design professionals and manufacturers.

Successful defense of a Lancaster County, Pennsylvania developer and general contractor and very successful resolution of one of the first EIFS construction defect cases in Pennsylvania, involving 140 single-family homes.

Represented 90 homeowners as plaintiffs in stucco litigation against the largest privately held home builder in the Philadelphia area which declared bankruptcy after several years of litigation and then litigated the matter in Bankruptcy Court and was successful in working with insurance company counsel for multiple insurance companies that were defending the builder as well as subcontractors to orchestrate a settlement for his clients as well as 130 additional homeowners represented by other law firms, culminating in a 70 page settlement agreement that obtained Bankruptcy Court approval and distribution of substantial funds to all 220 homeowners.

Represented one of three insurers as coverage, oversight and negotiating counsel in a recovery lawsuit brought by a national home builder against its subcontractors after the builder had remediated 917 homes in New Jersey and Pennsylvania; was the principal negotiator for all three insurance companies and successfully implemented a global settlement.

Represented Condominium Owners Association against builder, architect, and engineer for 40-unit condominium at the beach on the southern New Jersey shore with significant structural deterioration issues; guided Association through investigation, construction remediation project and then litigation which was settled just prior to trial.



Served as litigation consultant to major national insurance company's local counsel in Austin, Texas for two years in defending a multiple construction defect claim involving an entire townhouse condominium neighborhood. Instrumental in resolving this multi eight-figure case with a unique blend of money from insurers of all contractors, subcontractors, design professionals and manufacturers, first-party insurers, and a private investor who bought the entire neighborhood at a discount after the insurance money was contributed; with the private investor then remediating and reselling the neighborhood.

Consulted for New York based owner who was building an extravagant vacation home in St. Barthelemy using local and French construction companies and over \$1 million of windows from Switzerland; negotiated and drafted contracts and consulted on potential water intrusion issues and insurance issues.
